

Here is the brief for Friday 25 June 2021.

Testing increase Enhanced testing is continuing to be encouraged in Tillydrone, Froghall and Elrick and Westhill due to local surges in cases – and people living there are coming forward in large numbers in an effort to protect their communities.

Jillian Evans, head of health intelligence at NHS Grampian, said: “We have seen large increases in the number of people coming forward for both symptomatic and asymptomatic testing – and as we have seen in Moray that is the most effective way to drive down rates and keep people safe.

“We’ve seen close to a four-fold increase in testing in Tillydrone alone and we have just opened an asymptomatic testing site at the Tillydrone Community Campus. We are also seeing an increase in testing numbers in Froghall. In the Westhill area the number of people taking up testing has soared – about nine-fold versus the previous two weeks.

“All we can say is ‘thank you’ to people for working with us, doing the responsible thing and playing their part in protecting their family, friends and community. We really do appreciate it.

“If as many people come forward as possible, especially in these areas, for asymptomatic testing, then we can stop this new wave of cases from escalating out of control.

“From our previous work in Moray, we know it is possible to control surges without putting in place extra restrictions. In working with us, and continuing to do so, each and every member of the public plays a part in moving us forward.”

- General purpose detergent for general cleaning of reusable patient care equipment

- Combined detergent /chlorine releasing agents for rooms where a patient is known or suspected to have transmissible infection for both general cleaning, and terminal cleaning

- Blood and bodily fluid contamination continue to be handled as per chapter 9 of NIPCM for all 3 COVID-19 pathways (Red, Amber & Green)

- The Domestic Service are aware, that all clinical inpatient areas, including bedrooms, rest, treatment spaces, and touch surface cleaning should now revert to daily as per NHS Scotland National Cleaning Specification and staff rest areas will also have a daily domestic clean

- Safer workplace measures for COVID-19 will remain in situ, including cleaning of shared equipment, e.g. phones, computers, microwaves, desks etc

Safe management of linen and waste

All linen and waste will revert to Standard Infection Control Precautions (SICPs), and only be handled as infectious where patients are known or suspected to have transmissible infection.

Gentamicin is a high-risk antimicrobial and it is essential that all staff involved in the prescription and administration of Gentamicin in adult patients are familiar with this guidance.

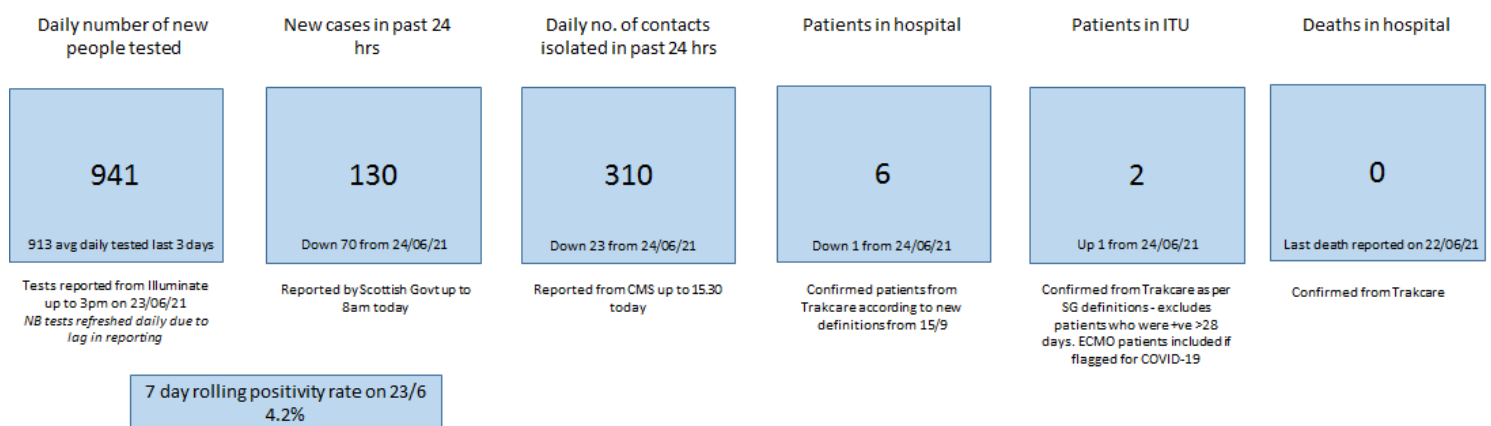
