Update to BASRiS form for disability assistance under special rules for terminal illness in Scotland Thank you for your assistance to date in delivering the new Scottish Government approach to disability assistance for individuals who are terminally ill. To ensure all clients are able to access their award from the earliest opportunity the BASRiS form has been amended to explicitly request that the date entered is the date of clinical judgement of terminal illness. This is to make it clear that, if different, the date the form is completed does not need to be entered.

The date which should be included on the BASRIS form is: the date on which a clinical judgment was made that the individual meets the definition of terminal illness. Importantly: the salient information is the date it is diagnosed that a person's condition is terminal, not the date the condition itself is diagnosed.

If Social Security Scotland have any uncertainty as to the date on which the clinical judgement was made, they may contact the clinician or their practice/organisation to confirm. It would be much appreciated if you could continue to assist the Agency to make payments to terminally ill individuals as quickly and fairly as possible by responding to any such queries.

Social Security Scotland previously sent BASRiS forms to GP Practices, Hospices, private practices, and NHS boards. These forms should now be destroyed. You can find out how to request new paper BASRiS forms on the Social Security Scotland website. Digital copies are available via SWAN.

Advanced brain imaging a first for Scotland NHS Grampian's John Mallard PET Centre has introduced a methionine PET CT imaging service in Aberdeen which will be of huge benefit to brain tumour patients across Scotland. PET-CT stands for Positron Emission Tomography and Computerised Tomography, a scanning method which measures tissue function rather than anatomy.

Clinical Scientist Professor Roger Staff explained: "We are pleased to be able to offer this service to people across Scotland. The Methionine PET CT service is unique in Scotland and only available at a handful of sites in the UK."

Mae Donald (63), whose pituitary tumour was removed thanks to the technology says she's been given a second chance in life and in her work as a home carer. Mae explained: "I am very impressed by the NHS. I am now free from medication, free from injections, free from everything and I'm a different person now. It is amazing what they can do and I forever grateful to the doctors and nurses who have helped me. I want to give a big thank you to the teams at Aberdeen Royal Infirmary and Fyvie Oldmeldrum Medical Group. The journey with them has been amazing." Read the full story.

ANTEC investigates whether less surgery in the armpit after neoadjuvant chemotherapy can be beneficial for those who have no remaining cancer cells in the armpit lymph glands.
