Christmas/New Year pay and on-call arrangements The designated public holidays over the festive period are:

- Thursday 25 December 2025 and Friday 26 December 2025
- Thursday 1 January 2026 and Friday 2 January 2026

The guide available via this link sets out examples of working patterns over the Christmas period. These examples, which apply to staff employed under Agenda for Change terms and conditions, equally apply to the New Year period. Managers and staff are encouraged to look at the example which covers the shift pattern appropriate to the situation; there is no need to look at every example.

The guide also outlines the arrangements where staff are rostered on call on a public holiday and provides examples. To stay consistent with other boards, there is a change of practice in relation to the time off in lieu for being on-call on a public holiday. This is effective for all public holidays, starting from 25 December 2025. Staff who are required to be on call on a designated public holiday are entitled to equivalent time to be taken off in lieu at plain time rates in addition to being paid an on-call session and any call outs. Please read the guide carefully to understand how this change will affect you.

Bin security in winter We have a legal duty to ensure our waste is secure. This becomes even more important during winter when animals - and sometimes humans - may seek shelter in large waste or recycling bins. There have been near misses, but luckily no-one has been injured. All exterior bins must either be stored in a secure area or having working lid locks.
