Superannuation contribution rates for Practitioners The Scottish Public Pensions Agency (SPPA) has published a circular advising of the superannuation contribution rates for employees that will be applied for 2025/2026. There is a significant change for Practitioners* who will now pay the highest contribution rate of 12.7% until a fully completed Annex D form is received by the payroll team. * A Practitioner can be medical, dental and ophthalmic practitioner, registered with their relevant Health Board Performers list. A medical practitioner is known as a GP and there are different classifications of GPs. Principal GPs are self-employed partners within a Medical Practice, whilst every other form of GP employment including self-employed locums are classified as Assistant GPs.
