**Agenda for Change non-pay reforms** Following a meeting of the programme board monitoring these reforms (reduction in the working week, the Band 5 nursing review, and a consistent approach to protected learning time) we can provide the following updates:

- Band 5 nursing review - we want to stress again this opportunity is open to ALL Band 5 nurses. We would particularly encourage those with specialist training to consider submitting an application, but it is open to any registered nurse employed on a Band 5 contract. We also want to confirm decisions on review applications are taken solely because of the evidence provided. There is no financial consideration as part of this process.
- Reduced Working Week - following the update from CET in yesterday's brief, we want to confirm all roster submissions will receive an email response. This response will include whether their submission, and backfill request if made, has been approved, and that clear information on the next steps for teams to follow based on the outcome of their submission will be provided. Notification emails will be sent in batches with the first batch of submission outcome emails being issued from later this week/early next week. Teams should not be concerned if they do not receive a submission notification in the first batch; further batches will follow. Please read this email carefully.

**Patient Placement Tool (PPT) - reminder and survey deadline extended** The infection prevention and control team continues to see low compliance with the Patient Placement Tool (PPT) completion during routine audits and reviews. Accurate and timely completion of the PPT is essential to ensure appropriate patient placement and to reduce the risk of cross-infection.

If you are responsible for in-patient admissions, you should complete and review the PPT as part of ongoing infection risk assessment at key points in the patient journey and whenever infection risk is identified or changes.
