**PVG Disclosure Scotland update** From 1 April, PVG membership became a legal requirement for all regulated roles with children and protected adults. **Wildlife and site/public safety** We are now well into seagull breeding season, during which time these birds can be especially aggressive. They can – and will – steal food of any kind and can injure you in the process. If you are eating outside on fine days, be vigilant and please make sure you dispose of all rubbish. We have invested in bins designed to prevent birds pulling rubbish back out of them; if these are full, take rubbish inside for disposal, remembering to recycle.

Under **no** circumstances should food be left out for any of the wildlife our sites may attract. Airborne fungal spores from bird droppings can enter general healthcare environments increasing the risk of various infections which birds can pass onto humans, such as Pasteurella infections, and Chlamydia psittaci, which can cause psittacosis (a respiratory infection).
