Appointment of a Site Director for ARI - message from Laura Skaife-Knight I am delighted to inform you Rick Strang, a nurse (trauma and ITU, specialising in A&E), has been appointed as the Site Director for ARI for a 12-month period.

Rick will join us full-time officially from Monday 5 January, but will be on-site for some days next month getting to know our teams, system, and improvement plan. This role, alongside a soon to be recruited to Deputy Medical Director (USC) (also fixed term), will provide strengthened clinical and operational leadership to support improvements to the timeliness of emergency patient care and safety. Rick will report directly to me as CEO in this next period and brings to the organisation comprehensive experience of improving urgent and emergency care pathways and performance.

Rick is currently the Improvement Lead for Urgent and Emergency Care and Deputy Chief Operating Officer at Royal Cornwall Hospitals NHS Trust. He has previously held the roles of Improvement and Programme Lead for the Emergency Department at Croyden University Hospitals NHS Trust, North West Anglia Foundation NHS Trust, Whittington Hospitals NHS Trust and has supported improvements as Director of Transformation with a focus on USC at King's College Hospitals NHS Trust and Liverpool University Hospitals NHS Trust.

Both fixed-term posts are being funded by Scottish Government as part of our escalation funding package.

- All IT equipment, regardless of age or condition, must be processed via the official Digital Directorate disposal procedure.
- If you have equipment for disposal, please complete the IT Equipment Disposal form which can be found on the Employee Service Centre or by following this link: IT Equipment Disposal
- Never attempt to remove or destroy hard drives or data storage devices yourself.

Following this process ensures sensitive data is handled securely. It also guarantees the disposal is conducted in an environmentally responsible manner. If you have any questions related to disposals,
