Extended use of fluid repellent surgical masks (FRSMs) – ARI and RACH On 12 December the request was made of all staff in – and visitors to – clinical areas of ARI to wear FRSMs. This recognised the high level of 'flu admissions and the prevalence of 'flu in the community. To give all staff certainty, this will remain in place at ARI across the Christmas/New Year period, to be reviewed in the w/c 5 January.

The extended use of FRSMs at RACH is being kept under regular review. Any changes to this will be communicated directly to the relevant teams.

Our strong advice to the public is not to visit relatives or friends in hospitals/care homes if they are experiencing respiratory symptoms (cough, sore throat, runny nose) or if they have had diarrhoea and/or vomiting.

Pay and Conditions of Service 2025-26 Policy for the Career Progression/Regrading of Specialty Doctor/Dentist Following publication on 2 December, we have now received Circular PCS (DD) 2025/02), [available via this link](#). As such, planning is underway to develop processes to assist individuals, services and managers in preparation for the regrading process. To flush, or not to flush The only items which should be flushed down any toilet are pee, poo, and (toilet) paper. Paper towels, wipes of all kinds, and period products should never be flushed; these materials do not break down like toilet tissue and are repeatedly causing significant blockages within our wastewater infrastructure.

Each blockage requires estates staff to be diverted from essential planned maintenance tasks to clear the system and prevent further damage. This reactive work not only increases operational costs but also reduces the time available for critical preventative maintenance that keeps our facilities safe, compliant, and functioning reliably. Wipes (even those which say they are safe to flush), paper towels, and period products must be disposed of in the appropriate bin.

Salary sacrifice scheme - green cars We are pleased to confirm all governance and contractual requirements have now been met for this scheme. Furthermore, we can announce we are partnering with Zenith to offer the purchase of a green car via a salary sacrifice scheme. There will be more information, including a target launch date, in the next month. Work on this scheme has taken longer

than initially expected; we are very grateful to you for your patience and your continuing interest in this scheme
