**PDF editing software – cybersecurity message** Over the last six months there has been an increase in the number of attempts to install PDF editing software on NHS Grampian devices. Downloading any unapproved software places the security of our devices at risk. Using work issued devices, the Edge browser can be used to view PDFs. PDFSam (available via the Software Center shortcut on desktops) can be utilised for accessing, viewing, and manipulating PDF files.

A new process for microbiology clinical referrals – now live Referrals to the Microbiology Clinical team should be made via email to <a href="mailto:gram.microbiologyclinical@nhs.scot">gram.microbiologyclinical@nhs.scot</a>. This service is in operation 9am-5pm, Monday to Friday. The team will endeavour to respond to any email received within one hour but will respond the same working day to all referrals received before 5pm.

For urgent queries, the telephone extension 50495 will also be in operation 9am-5pm, Monday to Friday. You may be asked to send your referral in an email if your call is deemed non-urgent. At weekends, and after 5pm during the week, referrals should be made via switchboard as per current arrangements, otherwise emails received outside of these hours will be responded to the next working day. 
