Error in Agenda for Change arrears for on-call allowances Arrears of pay for the 2025/26 pay uplift will be paid in July salaries. Unfortunately, the HR Service Centre have discovered the value of arrears being processed for on call allowances is incorrect and as a result some staff will be overpaid. The error only applies to staff who have been paid on call allowances this year and are therefore due arrears on this aspect of their pay. All other elements of arrears being processed for the 2025/26 pay award are correct. An inappropriate code was used which, rather than process the value of arrears due, generated a number of on call allowance payments. With e-payslips issued and wages due to arrive in bank accounts on Thursday, there is not enough time to amend salaries. As such, in accordance with financial procedures, those staff affected will receive correspondence by the end of this week advising on recovery of the money. A flexible repayment plan will be offered, commencing from August salaries. We realise this is situation is far from ideal and offer our sincere apologies.

**Managing staffing using the Common Staffing Methodology (CSM)** Using the CSM is part of our implementation of the Health and Care Staffing (Scotland) Act. To support its use a standard operating procedure has been agreed. The SOP is available via this link; this document aims to support and embed good governance and assurance processes.

At present, use of the CSM is only required for specific staff groups: nursing, midwifery, and doctors in Emergency Departments. Colleagues in nursing, midwifery, and medical teams will lead on this work to ensure consistent and evidence-based staffing decisions and to manage risk. Use of the CSM will also support financial good governance and delivery of a sustainable workforce model. The new module provides all the same functionality as the previous version of TrakED in a slightly better way but has the added benefit of Emergency Discharge Letters going directly to GPs electronically via SCI Gateway; replacing printing and posting to GPs via Royal Mail. This quick guide (networked devices only) highlights all the changes. Your access will automatically be updated on the dates relevant to your department. Any Pilot users, who have had two version of TrakED will find that their access to the old version will disappear. Support will be available to all users throughout the transition and e-Learning has already been updated to reflect the new Scottish Edition screens.
