Access to patient information Many of us access patient information during our work. Remember, every time we access patient data there must be a clear and legitimate patient care or administrative/operational reason to do so. If you've any doubts about whether it's ok to access patient data, check with your manager and/or Information Governance via gram.infogovernance@nhs.scot. We can and do review/audit access to systems.

Accessing data inappropriately can have significant negative consequences for our patients, for NHS Grampian, and for you. It can trigger HR, professional regulatory, or even criminal processes. Examples of things we must not do include looking at the medical information of friends and family, neighbours, colleagues, or our own medical records. If you're asked to care for a friend, relative or someone else who is known to you personally, let your manager know so appropriate steps can be taken.

Foresterhill Health Campus car parking We previously advised our new car parking management scheme at Foresterhill would start in late October/early November. Unfortunately, we do not have a confirmed start date yet; please be assured work is underway to fit the required barrier technology and the 'go-live' date will be shared in this brief. In the meantime, a few things to remind you of:

- The car parking registration form is still open via this link and will remain open this is a rolling process.
- Registering to park will not guarantee you a space; if no staff parking is available, you will be expected to park off site.
- All previously issued permits will be void; you must register using the above form if you wish to use staff parking at Foresterhill.
- We are **not** issuing new permits as part of this scheme; we will use number plate recognition instead.
- We encourage everyone who is able to use public transport or active travel like cycling or walking to do so

Medicine Safety Week From today, until Sunday, there's an extra focus on medicine safety. The theme of this year's event is 'We can all help make medicines safer'. Anyone can report an issue with a medicine, vaccine, medical device, or blood product via the Yellow Card scheme. You **don't** have to be in a clinical role or even working for the NHS. Dr Gray's to host mobile MRI unit From 1 December until the end of March 2026, a mobile MRI unit will be in placed at DGH. Funded by the Scottish Government, this will increase scanning capacity and help reduce waiting lists. Patients eligible for the unit will be contacted directly to be offered an appointment; those requiring complex scans, or with mobility needs will continue to be seen in Aberdeen.

The team will endeavour to respond to any email received within but will respond the same working day to all referrals received before 5pm.

For urgent queries, the telephone extension 50495 will also be in operation 9am-5pm, Monday to Friday. You may be asked to send your referral in an email if your call is deemed non-urgent. At weekends, and after 5pm during the week, referrals should be made via switchboard as per current arrangements, otherwise emails received outside of these hours will be responded to the next working day.
