**CDU update** Our Chief Executive, Laura Skaife-Knight, and Executive Nurse Director and Deputy Chief Executive June Brown would like to share their thanks and appreciation for efforts to get our Central Decontamination Unit at Foresterhill back up and running.

*We would like to extend our heartfelt thanks to all of the staff who have supported the extensive Central Decontamination Unit (CDU) refurbishment and recovery work over recent months. Thanks to your collective effort, the unit will begin processing this morning as training gets underway for staff. The installation of the first of our new CDU machines has been completed on schedule and this is an important milestone in restoring full capacity. Your exceptional commitment throughout this challenging period is greatly appreciated, has ensured that disruption to patients has been minimised and the resilience of this vital service has been improved.*

**Scottish Quality and Safety Fellowship (SQSF) Cohort 18 applications open** The SQSF is built around a series of distance learning, coaching, and focused residential workshops. All Fellows undertake an improvement project throughout their participation on the programme and are expected to work on this as part of their day job. It is open to healthcare staff who currently undertake clinical practice and have a direct influence on improving the delivery of safe patient care, as well as staff in clinical professions who do not currently deliver hands-on care but do have a role in improving patient care or safety.

Selection will be by application and interview. The application pack and person specification is available [on Turas by following this link](#). Applications close at 10am on Friday 10 April. Colleagues are asked to submit their draft application to [gram.qiat@nhs.scot](mailto:gram.qiat@nhs.scot) by 12 noon on Friday 21 March to allow time for review and executive sign-off. Interviews will be held online during w/c 8 June. **Reduced Working Week update** A new online [RWW P/T Hours Retention Form](#) is now available for managers to share details of any part-time member of staff who it has been agreed will retain their current part-time hours when the final reduction for the Reduced Working Week (RWW) is implemented on 1 April 2026. This form should not be used for any other purpose and should be completed by 15 February.

The new form is a substitute for an eESS transaction for RWW only. The details provided on the form will be used to retain the member of staff's current part-time hours on eESS, Payroll and SSTS/Optima. No other system notification is required.

Please note the form must not be used for changes to part-time hours that are not related to the retention of hours from 1 April 2026. The normal process applies for all other changes to part-time hours i.e. an eESS transaction and for Optima rosters advance notification to the eRostering team.

**ICYMI - assessing the value of NHS outdoor spaces** The NHS Scotland Climate Emergency and Sustainability Strategy requires all health boards assess the value of the benefits arising from use of the NHS outdoor estate. The University of Aberdeen and Public Health Scotland (PHS) are carrying out research to understand the health and wellbeing and economic values of the NHS Scotland outdoor estate to those working at NHS Scotland sites.
