Introduction

This annual procurement report has been published by NHS Grampian in accordance with the Procurement Reform (Scotland) Act 2014, which requires that, "all public bodies which expect to have spend of £5 million or greater on regulated procurements in its next financial year must produce a procurement strategy". This report covers the reporting requirements for NHS Grampian for 1st April 2021 to 31st March 2022.

NHS Grampian provides health care services for the half-million people in the Grampian area and in financial year 21/22 had a trade spend with third party suppliers of around £240m, the breakdown of the top 10 categories can be seen in Figure 1.



These works, products and services are sourced through regional and national framework contracts where possible. Within NHS Grampian the Procurement Service and the following areas have designated procurement responsibility; Pharmacy, Laboratory Medicine, E-Health, Medical Equipment Management Services, Planning, Innovation and Programme and Estates and Estates Projects.

This annual report is an opportunity to review delivery against the commitments made in the NHS Grampian Procurement Plan 2018-2023. This report demonstrates NHS Grampian's commitment to ensure that the procurement spend is being used effectively to achieve best value and safe operation of services in conjunction with achieving social, economic and environmental outcomes in our area.

The Procurement Service in NHS Grampian provides a comprehensive procurement and supply chain service. Undertaking contract development, implementation activities and ensuring supply chain resilience while providing leadership and support to the devolved procurement areas within NHS Grampian.

NHS Grampian also publishes its Asset Management Plan on its website and updated status on the associated major Capital Infrastructure Procurements.

Review of Regulated Procurement Compliance

NHS Grampian's procurement activities support organisational policy priorities by ensuring that required works, products and services are delivered at best value and are fit for purpose. The detailed breakdown of the procurement activity for 21/22 is available in Annex A.

NHS Grampian adheres to the Procurement Journey methodology for all of its purchases where a tendering procedure is required and all of the regulated procurement activity listed above has been carried out in accordance with the NHS Grampian Procurement Plan 2018-2023.

NHS Grampian use the Fraud & Organised Crime Impact Assessment (FOCIA) tool to receive an assessment of the risk of fraud, corruption and serious organised crime impacting on regulated procurements. Engagement is initiated with a Counter Fraud Specialist where any procurement activity is assessed to be of higher risk. NHS Grampian continue to collaborate with National Procurement and other Health Boards and have provided input into the procurement process and implementation of the new national inventory management system which will provide visibility of local stock use for both NHS Grampian and National Procurement, leading to improved patient care. In this financial year NHS Grampian implemented Phase 1 (transfer of Ward Product Management functionality) of the new national inventory system. On a regional level NHS Grampian Procurement Team are working with colleagues in eight East & North Health Boards to scope a future operating model for procurement to create value and streamline processes across the participating Boards.

Section 18(2) of the Act states that it is mandatory for an annual procurement report to include "a summary of any community benefit requirements imposed as part of a regulated procurement that were fulfilled during the year covered by the report". At the tender development stage NHS Grampian consider community benefits within each Procurement Strategy and therefore, community benefits are considered in all regulated procurements.

In 21/22 NHS Scotland National Procurement launched the Community Benefits portal and Procurement is working closely with local Public Health colleagues to further enhance the community benefits delivered through this portal. NHS Grampian have also now achieved Living Wage Accreditation.

During 21/22 community benefits continue to be delivered against The Baird Family Hospital and The ANCHOR Centre construction projects which amount to a c. £244 million building development on the Foresterhill Health Campus in Aberdeen. The new buildings will provide modern healthcare facilities to support and enhance the provision of clinical care delivered by NHS Grampian.

Community benefits have been a feature of delivering these new facilities from the outset and NHS Grampian has been involved with Graham Construction in ensuring there has been a particular focus on the creation of opportunities for Small to Medium sized Enterprises (SMEs) and Third Sector partners. In support of this, 'meet the buyer' events were held in Aberdeen and Inverness.

In the period since the previous report, community benefits have been delivered resulting in 18 new apprentices being employed, 3 new graduate roles being created; 23 new entrant employment opportunities providing employment for more than 26 weeks and 2 work experience placements.

In addition, 6 NHS Grampian apprentices will be given the opportunity to work on the new developments through a partnering arrangement with Graham Construction and their supply chain. There has also been involvement with the Third Sector through the entering into arrangements with Charlie House to provide the on-site catering facility for the workforce.

Graham Construction are also taking forward initiatives for engaging with local schools and universities and have offered site visits to university students as well as presenting to schools on the projects and are taking forward initiatives to highlight opportunities in the industry for both men and women.

Sustainability in construction is at the heart of delivering these new buildings and Graham Construction have waste management plans in place to suitably reduce construction waste and are also engaged in the Considerate Constructors scheme where they are consistently achieving more than the required levels of performance as agreed with NHS Grampian.

NHS Grampian adhere to the obligations outlined in the Sustainable Procurement Duty which require public bodies to consider what improvements can be made to social, environmental and economic wellbeing and there has been some good work happening across the organisation to support NHS Grampian's sustainability goals. As an example, Facilities and Estates awarded the maintenance of the medical gas pipeline systems to a supplier who scored very highly on sustainability criteria. They have several innovations that can support with driving down whole life costs and they also have ISO accreditation for environmental management.

NHS Grampian are committed to ensuring that all suppliers who are awarded business are paid promptly and the terms of award require prompt payment to suppliers throughout the supply chain. NHS Grampian are committed to working with suppliers to encourage fair working practices and where relevant and proportionate fair work practices are included as a scored element of local tender processes.

Future Regulated Procurements Summary

As detailed in the Procurement Plan, NHS Grampian put transparency at the centre of procurement activity. NHS Grampian will continue to advertise procurement opportunities to give suppliers notification of upcoming opportunities to ensure competition and value for money.

During the next 24 months (April 2022-March 2024) NHS Grampian expects to carry out the following regulated procurement activity, however these may be subject to change in response to budget allocation cycles.
