

# Patient Safety: Prescribing of 'Higher' Strength Buprenorphine Transdermal Patches

## Summary

When prescribing 'higher' strength buprenorphine patches (i.e. 35, 52.5 or 70 micrograms/hour) to ensure that patients receive an appropriate product with directions detailing the correct frequency of application, it is recommended that:

- Prescribing is done by brand name Bupeaze<sup>®</sup>, and
- Prescribed directions should be clear: <u>Bupeaze®</u> should be replaced after 96 hours (4 days) at the latest. For convenience of use, the transdermal patch can be changed twice a week at regular intervals, e.g. always on Monday **morning** and Thursday **evening.**

This information relates to higher strength buprenorphine patches only, 'lower' strength patches (i.e. 5, 10, 15 and 20 micrograms) should be prescribed generically.

#### **Rationale**

- The <u>Specialist Pharmacist Service</u> lists buprenorphine patches as a medication which they recommended to be prescribed by brand name to "reduce the risk of confusion and error in dispensing and administration" and the <u>Scottish Palliative Care Guidelines</u> recommend that "patients should ideally stay on the same formulation and should not switch between patches".
- Various brands of 'higher' strength buprenorphine patches are available.
- All brands of 'higher' strength buprenorphine patches have the same licensed indication: "Moderate to severe cancer pain and severe pain which does not respond to non-opioid analgesics. Not suitable for the treatment of acute pain".
- Some brands directions for use indicate patches should be replaced every 3 days, while others indicate changing every 4 days.
- Bupeaze® has been selected as the NHS Grampian preferred brand of 'higher' strength buprenorphine patch, as they represent the best value for money when compared with other brands.
- Bupeaze® patches should be replaced after 96 hours (4 days) at the latest. For convenience of use, the transdermal patch can be changed twice a week at regular intervals, e.g. always on Monday morning and Thursday evening the Patient Information Leaflet has useful information regarding days of changing.



## **Actions Required**

## **Primary Care**

- All patients prescribed 'higher' strength buprenorphine patches should be prescribed by brand Bupeaze® with directions as detailed above.
- Patients currently prescribed 'higher' strength buprenorphine patches either generically or as a brand other than Bupeaze® should be switched to Bupeaze® prescribing (unless there is clinically significant reason to not switch which should be documented in the patients notes).
- Any patients discharged from secondary care on a brand of 'higher' strength buprenorphine patch other than Bupeaze® should have prescribing changed in line with this recommendation.
- Ensure all patients being prescribed buprenorphine patches are counselled on directions for use, ensuring the frequency for changing patches is highlighted to the patient.
- Where changes to prescribing are being made practices should liaise with their local community pharmacies to coordinate this change and minimise stock wastage.

#### **Secondary Care**

Where a patient is being discharged from secondary care and there is a need for ongoing prescribing of a 'higher' strength buprenorphine patch this should be recommended either generically or as the NHS Grampian preferred brand (Bupeaze®).

## **Community Pharmacy**

Where patients are prescribed buprenorphine patches ensure they are counselled on the directions for use, ensuring the frequency for changing patches is highlighted to the patient.

## **NHS Grampian Preferred Brand**

It should be noted that the NHS Grampian preferred brand of buprenorphine patch is subject to change, owing to product availability and procurement costs.

## Formulary and ScriptSwitch

To support these recommendations Grampian Area Formulary information and ScriptSwitch messaging will be updated to reflect changes.
