Recording Pharmacotherapy Activity

Within Primary Care NHS Grampian we have been using NATIONALLY agreed pharmacotherapy read codes. They fulfil most of the activities we undertake in level 1 and level 2 activity but are not specific enough for level 3 activity or have included level 0 activities. Pharmacotherapy teams should use and become familiar with the revised read codes to be used across all Primary Care within NHS Grampian.

Vision users should save the 'Pharmacotherapy Activity' Guideline on a tab within their consultation manager and enter the data
using the Guideline. The guideline along with Instructions on downloading and setting up Tabs can be found here

Please note, when clicking on some buttons within the Guideline you will be prompted to record where to save the 'clinical data'. It's important to ALWAYS choose 'Enter in General History'.

When manually entering a Read Code in Vision you must also ensure that it is entered as a "Medical History" and not a medication recall. You can quickly enter Read codes by pressing F2 and only the agreed Read Codes from the table below should be used. Please remember to add a # in front of the codes when entering manually

- All entries should be recorded following the SP3AA guidance on "Good practice guidance for GP Practice Pharmacy Staff recording
 in patients' records within NHS Scotland" 2021 using the SBAR format where appropriate.
- Staff are reminded to ONLY use one code. If more than one code would be suitable use a single code but choose the 'highest level' code appropriate. The exceptions to this when an additional read code should be recorded are when:
 - o an IP signs a prescription and has to record the 'prescription by supplementary prescriber'
 - o a failed encounter when trying to contact/telephone a patient
 - a significant problem (Emis) / Priority 1 (Vision) should be added to appear on a patient's Emergency Care Summary e.g.
 compliance aid
 - a serial prescription is issued for this first time following a review, the review is the higher level code so code level 1 #66RE in addition to the review.

Pharmacist polypharmacy review Polypharmacy Medication Review	Full polypharmacy medication review by pharmacists with emphasis on high level complex reviews. Review should be undertaken utilizing the 7 steps of polypharmacy review and is not defined by the number of medications a patient is taking. Generally, involves high risk patients or high-risk medications, frail patients, care homes, care at home, patients on anticipatory care, frequent hospital admission or high health gain patients.
