Integration Joint Boards – Regular Update Report (August 2025)

1. Actions Recommended

The Board is asked to note the latest approved minutes of the meetings of the Aberdeen City, Aberdeenshire and Moray Integration Joint Boards.

2. Strategic Context

Three Integration Joint Boards for Aberdeen City, Aberdeenshire and Moray were established on 6 February 2016 under the terms of the Public Bodies (Joint Working) (Scotland) Act 2014 with full delegation of functions and resources to enable integration of primary and community health and social care services effective from 1 April 2016. Each IJB is a separate legal organisation and acts as principal in its own right.

The principal ambitions of health and social care integration are to:

- Support the improvement of the quality and consistency of services for patients, carers, service-users and their families.
- Provide seamless, joined-up quality health and social care services in order to care for people in their homes or a homely setting where it is safe to do so.
- Ensure resources are used effectively and efficiently to deliver services.

3. Key matters relevant to recommendation

This report presents the NHS Grampian Board with the latest approved minutes from the Aberdeen City, Aberdeenshire and Moray IJBs. The key highlights are emphasised below.

3.1. Aberdeen City

The City IJB met on 13 May 2025 and the minutes from that meeting were approved on 1st July 2025.

The key highlights from that meeting were;

- 1. Financial Position Update Year End Report: The Board considered the 2024/25 revenue budget draft outcome, prior to audit, for the delivery of the IJB responsibilities; and an update on the 2025/26 year budget savings, prepared by the Chief Finance Officer. The Board noted the 2024/25 IJB draft outturn position, additional in-year funding, progress on the 2025/26 budget savings, and approved the transfer of funds from the Prescribing budget to the Adult Social Care budget.
- 2. **Annual Review of Financial Regulations and Reserves Policy**: The Board approved the revised Financial Regulations and Reserves Policy, including

- instructing the Chief Finance Officer to include sensitivity analysis for all future budget forecasting.
- 3. Recruitment and Selection Process for Chief Finance Officer: The Board agreed to the proposed approach for recruiting a Chief Finance Officer of the IJB (ACHSCP).
- 4. **Annual Resilience Report**: The Board considered the report providing assurance on the IJBs resilience arrangements and agreed that their duties as a Category 1 responder under the Civil Contingencies Act 2004 were being met.

Aberdeen City IJB Medium Term Financial Forecast

Aberdeen City IJB met on 2nd July and were presented with a report from the Chief Finance Officer providing an estimated 4 year Medium Term Financial Forecast (MTFF).

The summary position below highlights that the IJB will require to make significant savings of what could be around £14.045m, dependent on service demand, in 2026/27 – reflecting full delivery of the £14.354m savings in 2025/26. The work in the next two financial years, 2025/26 and 2026/27, is required in the main to remove the structural deficit the IJB has been carrying.

The actual outturn for the 2024/25 budget year reflects an overspend of £24,399,000. Both funding partners have been made aware of the year end position of the IJB and have expressed support for funding that position. Additional funding from partners as noted above was formally requested to ensure that Aberdeenshire IJB can achieve an overall balanced position as at 31 March 2025.

3.3 Moray

The NHS Grampian Board has the minute from the meeting of the Moray Integration Joint Board (MIJB) held on **29 May 2025** and accepted as a correct record at their meeting on the **19 June 2025**. The key highlights from the **May** meeting for the NHSG Board to note are, the MIJB:

29 May 2025

- Noted a report informing members of changes to membership of the Moray Integration Joint Board (MIJB), Audit, Performance and Risk Committee and Clinical and Care Governance Committee.
- Approved the final draft of the Strategic Delivery Plan (2025-2028). Noting a report will be submitted to Audit, Performance and Risk Committee in September 2025 with proposals for future reporting of key performance indicators.

- Subsequent to the meeting it was agreed to move the Audit, Performance and Risk Committee from September to October 2025.
- Approved the new format of the MIJB Risk Register and noted its continued development.
- Endorsed the updated Moray Mental Health and Wellbeing Strategy Delivery Plan 2024-2026 and endorsed the Moray Mental Health and Wellbeing Strategic Performance Framework.
- Approved the final MIJB Equality Mainstreaming Progress Report 2021-2024 and approved the MIJB Equality Outcomes for the period 2025-2029 aligned with the strategic priorities outlined in the MIJB Strategic Plan 'Partners in Care 2022-2032'.
- Noted progress made by the Moray Drug and Alcohol Partnership (MADP) in delivery its strategic priorities for the period 2024/25, as captured in the Scottish Government's (SG) Annual Reporting Survey, and gave approval for submission to the SG in line with national reporting requirements.
- Approved proposed changes to the MIJB Financial Regulations, noting reviews will be done biennially.

MIJB Revenue Budget Outturn 2024.25

 The actual outturn for the 2024/25 Core Services budget year reflects an overspend of £7,420,760. This has resulted in a recurring budget pressure of £5,987,722 for the 2025/26 financial year. The ongoing impact of this overspend will be monitored closely and reported regularly to the MIJB.
